1. INTRODUCTION:

1.1. Assam Petrochemicals Limited (APL) was set up to utilize the huge reserve of Natural Gas in the Upper Assam oil fields and also to meet the requirement of increasing national demand for Methanol and Formalin. Incorporated in 1971, the company was a pioneer in the field as it was the first to manufacture petrochemicals in India using natural gas as feedstock. Its Petrochemical plant was set up in Namrup, Dibrugarh Dist. of Assam.

Assam Petro-Chemicals Ltd. is now implementing a mega project of 500 TPD Methanol and 200 TPD Formaldehyde plant as an expansion project of the company at a total cost of Rs. 1709 crores. The Hon'ble Prime Minister of India, Shri Narendra Modi virtually dedicated the 500 TPD Methanol Plant of the Company in service to the Nation on 14.04.2023. Besides the project work of 200 TPD Formalin Plant in Boitamari of Bongaigaon district is well in progress. Government of Assam, Oil India Limited and Assam Gas Company Limited are investing in equity capital for implementation of 500 TPD Methanol and 200 TPD Formalin project. Government of Assam along with Assam Gas Co. Ltd and AIDC Ltd. will hold 51% of shares and Oil India Ltd. will hold 49% of the equity capital of the company.

1.2. The site for the New Plant:

The new 500 TPD Methanol Plant is set up in the land area adjacent to existing location of APL factory at Namrup.

1.3. Approach to site:

The APL factory is situated at Namrup in the district of Dibrugarh, Assam, India. Namrup is connected with Dibrugarh by national Highway NH-37 and is at a distance of around 70 KM from Dibrugarh and around 65 KM from Dibrugarh Air Port. The nearest railway Station is Namrup Station and is at a distance of 9 KM. The Station has siding facilities suitable for handling Project equipments. The Railway Track is Broad Gauge.

1.4. The Plot area has an existing Natural ground level of 124.4 m from the MSL.

2. SCOPE OF WORK:

a. The brief scope of work shall comprise of round the clock Routine, Preventive, Breakdown and any emergency nature job for APL Township & associated area to supply 24*7 Power at Township & other associated area. The vendor shall maintain proper and detailed records for the job carried out by their employees and shall also maintain all records and returns as necessary for carrying out the work smoothly. All jobs to be carried out in consultation with APL Engineer Troubleshooting of related problems along with root cause analysis for prevention of repetitive failures is in the scope of work. The contractor must also assist APL engineer with day-to-day routine activities and planning, providing solutions for system improvement and to increase reliability of the system.

3. BIDDER'S QUALIFICATION CRITERIA:

a) TECHNICAL:

1. Bidders should have experience in successful completion of similar works (Similar work means Annual Electrical Township maintenance works in any government organization / PSU / Private Sector companies) during last 7 (Seven) years as on date of publication of Tender. The completed similar work experience should be any one of the following:

3 (Three) similar completed services each costing not less than Rs. 9,71,000/-.

Or

2 (Two) similar completed services each costing not less than Rs. 12,13,750/-.

Or

1(One) similar completed services costing not less than Rs. 19,41,999/-.

- Bidder shall not be an employee in Government/Quasi Government/Public Sector Undertaking and/or dependant of an employee of Assam Petro-chemicals Limited in service.
- 3. The Contractors/ Agencies should be in possession of necessary manpower, tools, plants, equipments & machineries required for carrying out the Job. APL would not provide any materials for the execution of the Job.

b) COMMERCIAL:

- To be eligible, the contractor should have a sound financial background and average annual turnover for the last three financial years, ending 31st March viz. 2022-2023, 2021-2022 and 2020-2021 should not be less than Rs. 7,28,250.00.
- 2. The Income Tax Return of the last 3 (three) financial years must be submitted along with the Bid documents.
- 3. The bidder shall have earned a net positive profit for the last three consecutive years.
- 4. The bidder shall submit copies of balance sheet and Profit & Loss Account duly certified by CA for the last three financial years [for Financial Year 2020-21, 2021-22 & 2022-23] for the proof of turnover.



4. SPECIAL TERMS AND CONDITIONS FOR ANNUAL MAINTENANCE OF APL TOWNSHIP FOR THE YEAR 2024-25:

- a. The contract will be for a period of 1 (one) year with effect from **01.11.2024** to **31.10.2025**. However, if the performance of the contractor is not found to be satisfactory, then the contract may be cancelled any time before completion of the stipulated period.
- b. The contractor will have to post requisite number of workmen for 24 X7 (Round the clock)
- c. In addition to the township the following area are included in the scope of work APL Technical building, Township deep tube well maintenance, Mechanical workshop, Administration office & HRM office, Project office & Civil office, Store, Instrumentation office, Despatch office, Telephone Exchange, SCVO Office, street light (township &plant).
- d. The Contactor must ensure that workmen must be present in Sundays & Holidays.
- e. Contractors having up to date renewed Electrical License of required grade applicable to 415 volt overhead lines, Electrical supervisor's certificate of Competency, in Form B, issued by Electrical Licensing Board, Government of Assam, holding supervisors under their employment. The Electrical supervisor's certificate of Competency holder should be associated with the Contractor / firm and should be duly endorsed by the Electrical Licensing Board.
- f. The Contactor must ensure that if any breakdown/fault occurred in the Overhead transmission line due to heavy rain/storm/any reason what so ever the breakdown job must be attended immediately to restore normalcy
- g. The contractor will have to pay the workmen engaged for the above work wages as per prevailing Govt.'s rules.
- h. Payment of wages to the workmen must be made in presence of the authorized representative appointed by APL within the office hours as per provision under contact Labour Regulation Act, 1970. Wage payment sheets duly certified by the contractor with signature of receipt by the workman shall have to be submitted along with monthly bill.
- i. No advance will be admissible without bill. Even if the payment of bill is pending upto 2 (two) months for reasons whatsoever, the contractor shall have to make regular monthly payment to the workmen so that work is not suffered.
- j. Any additional manpower for attending any kind of job is in the scope of contractor.
- k. After the expiry of initial one year contract period, extensions may be given for a period of one (01) year duration upto a maximum total duration of two (02) years inclusive of the initial one year period. Such extension of contract shall be offended



only if the performance of the contractor during the concluded contract period is found to be unsatisfactory by the owner (APL). However APL shall reserve the discretionary authority not to offer any extension of the contract period.

- I. Rates agreed shall remain firm for a period of two (02) years from the date of work order.
- m. No article or materials except those mentioned in the scope of supply will be issued to the contractor, the contractor must arrange all their materials not mentioned in the schedule of materials on their own account.
- n. APL cannot guarantee time of arrival of materials to be issued by the APL. APL will not entertain any claim or compensation should there be any unavoidable delay in supply of materials except granting reasonable extension of time for completion of work.
- Quantity mentioned in the schedule of work is approximate, however actual volume
 of execution may vary and no extra claim for each variation will be entertained.
 Payment will be made at actual measurement only.
- p. The contractor will follow all safety rules and regulations relevant for the job. Company's safety and security rules shall be strictly adhered.
- q. 3QUANTITY VARIATION: The quantity of item in BOQ may vary on either side i.e. below or above due to prevailing condition at the time of execution of contract and contractor shall not claim any compensation due to quantity variation
- r. Gate passes and identity cards will be issued to enter into the premises of the Company subject to the verification of character antecedent by police. In case the identity cards are lost, it is the responsibility of the contractor to ensure that the identity cards are not misused
- s. The management will neither provide any accommodation nor give any land for construction of quarters for his employees. It is the responsibility of the contractor to provide accommodation to the worker in nearby area for smooth operation.

5. TECHNICAL SPECIFICATIONS & SCOPE OF WORK:

- a. The work will be carried out as per BOQ enclosed in Price Bid. In case of any doubt regarding the specification and its quality of work, Engineer in Charge's clarification and decision will be final and binding on the contractor.
- b. All the materials except the materials issued by APL free of cost shall be arranged by the contractor. The materials should be conforming to the relevant IS codes of latest revision.
- c. All tools and tackles required for proper completion of work shall be arranged by contractor.



d. The contractor should extend fullest co-operation with the third party agencies engaged, if any by APL to adhere the Quality Control Procedures ensuring quality.

- e. The contractor should extend full co-operation to the other contractors who may be doing other works in the same area to enable them to execute their portions of work without any delay or difficulty.
- f. The Engineer in charge will communicate or confirm his instructions to the contractor in respect of the execution of the work in a "work site order book" maintained at his office and confirm receipt of such instructions by signing the relevant entries in this book. Such entries will rank as order or notices in writing within the intent and meaning of these conditions

6. SUPERVISION & EXECUTION OF WORK:

i. The contractor will deploy sufficient numbers of Supervisors/ Engineers and technician of appropriate qualification and experience to ensure proper execution of work. The supervisors of qualifications Diploma in Electrical Engineering and the Engineers of qualification B.E./ B.Tech in Electrical Engineering shall be deployed by the contractor. They will carry out instructions of Engineer-in-charge and other senior officers of APL during the progress of work.

7. QUALITY OF WORK:

- a. After the award of work, the contractor shall prepare and submit quality assurance program and schedule for work completion / comply with any other quality plan requirement and schedule for work completion proposed by APL with all details and indicate the field equipment that he is going to use for quality assurance.
- b. Any work found defective / unsatisfactory the contractor has to rectify the same at his own cost. In case the contractor fails to rectify the defects within a specified time as per the Engineer in –charge's instructions the same will be got done by APL at the risk and cost of the contractor and the cost deducted from the contractor's bill.
- c. Regular meeting (fortnightly or as decided by APL) shall be held between APL and contractor to review the issues related to progress, penalty, quality and any other aspect.

8. SITE CLEARANCE:

- a) Written permission for erection of temporary work sheds at site will have to be obtained from APL
- b) Once the work is completed, the contractor shall remove his temporary shed and the unwanted materials and also dispose the debris as instructed by the Engineer in charge.



c) Final bill shall be forwarded only after clearance of site as per the satisfaction of Engineer-in-charge

9. GENERAL SAFETY PRECAUTION TO BE FOLLOWED AT WORK SITE DURING EXECUTION TO BE TAKEN BY THE CONTRACTORS:

The Contractor must inspect the area of work to decide the safety precautions necessary for executing this contract. All the personnel protective equipments (PPE) are in the scope of contractor. The following safety measures should be strictly adhered to during execution of works at sites.

- a. Whenever people work at height more than six feet, platform shall be provided or the workers shall wear safety belt to avoid fall from the height.
- b. Wherever any area declared as dangerous, the workers shall not be allowed to work till a written clearance is obtained from appropriate authorities.
- c. No material of any kind shall be dropped or allowed to be dropped from any height.
- d. Defective ladders shall not be used at all.
- e. All excavations must be barricaded and red lamps must be provided.
- f. No work should be taken up of execution inside shop floor / factory premises, without obtaining necessary work permit.
- g. Providing helmet for high level work
- h. All personal protective equipment conforms to standard specification as per the details given in the code of conduct.
- i. The necessary safety equipment's such as gloves, boots, helmets etc. must be issued to the
- j. workmen and strictly to be used while carrying out the work.
- k. Providing dust or fume respirator in places where dust and fume concentration exist.
- I. Providing goggles and welding screens.
- m. Providing acid and alkali proof rubber gloves for handling acid and alkali and chemical which are corrosive.
- n. Providing rubber gloves for working on electrical works.
- o. All temporary electrical connections shall be properly earthed, insulated and periodically checked.
- p. Inflammable materials shall not be stored near places where the sparks are likely to occur.
- q. The gas cylinders must be always handled on trolleys or kept tied down when not in use. They should never be rolled as Roller for conveying.
- r. If the contractor fails to improve the standards of safety in its operation, to the satisfaction of APL, after being given a reasonable opportunity to do so and / or / if the contractor fails to take appropriate safety precautions or to provide necessary safety devices and equipment or to carry out instructions regarding safety issued by the authorized APL official, APL shall have the



right to take corrective steps at the risk and cost of the contractor, after giving a notice of not less than seven days, indicating the steps that would be taken by APL.

5. INSTRUCTION TO BIDDER:

- i) Rates quoted should be inclusive of all taxes and duties but exclusive of GST.
- ii) The successful bidder has to execute an agreement with APL in a non-judicial stamp paper of denomination not less than Rs. 100.00 within 10 days after issue of LOI / Work Order. The format for the same is per ANNEXURE-II.

- x) The bidder may at its own discretion can examine the site of works and its surrounding and obtain for itself on its own responsibility all information that may be necessary for preparing the bid and entering into the contract. Claims of any kind due to variation or ignorance of site conditions and environment conditions will not be eligible in any circumstances.
- xi) Failure to furnish all the information required by the bidding documents or the submission of a bid not substantially responsive to the bidding document in every respect may result in the rejection of the bid.
- xii) The CONTRACTOR shall ensure compliance with all statutes, laws, rules and regulations of the Central or State Government or any other authority such as the Workmen's Compensation Act 1923, Payment of Wages Act, Minimum Wages Act 1948, Employees State Insurance Act, Employees Provident Fund Act, etc. and any and all statutory modifications thereof in connection with employees engaged by him or his sub-contractors in the work including proper insurance coverage.

- xv) INSOLVENCY OR INABILITY TO PERFORM THE CONTRACT SATISFACTORILY:

If the contractor's performance of any portion of it or his subsequent rate of progress is unsatisfactory, the Company shall have the power to declare the contract to an

end. In case, the contractor shall be liable for any expenses or damage, which the Company may incur in connection with contractor's default will be recovered from the Contractor and security deposit shall stand forfeited.

xvi) **BID VALIDITY**: Bid validity period is 180 days from the DUE DATE or EXTENDED DUE DATE.

xvii) FORCE MAJEURE:

- i. Neither the contractor nor the company shall be considered in default of it obligation hereunder, if such performance is prevented or delayed of war, hostilities, revolution, flood, earthquake. Civil commotion or because of any law and order proclamation or ordinance of the Govt. Or of any other cause beyond the reasonable control of the party effected.
- ii. Should one or both parties be prevented for fulfilling contractual obligation by a state or force lasting continuously for a period of six months the two parties shall consult together regarding the future execution of the agreement.

xviii) ASSIGNMENT OF SUB-LETTING OF CONTRACT:

The contractor shall not assign or sub-let the contract or any part thereof or allow any person interested therein, in any manner, whatsoever. Any breach of this condition shall entitle to take such steps as may be necessary and also terminate the contract. However the contractor can assign / depute his authorized representative to look after the job including billing, receipt and payment to his worker already engaged for the job.

xix) APPLICABILITY OF LAW AND JURISDICTION: The contract shall be governed and interpreted in accordance with applicable laws of India as well as the state of Assam. Any suit or proceedings to enforce the rights of either of the parties hereto under this contract will be instituted in and tried by the courts of Dibrugarh only in the state of Assam and by no other courts and both the parties hereto hereby expressly agree to submit to the jurisdiction of such courts.

xx) AGREEMENT

On acceptance of the tender, the contractor has to execute an agreement on Non Judicial stamp paper of Rs. 100.00 (Hundred) only at his own cost within 10 (Ten) days from the date of receipt of the order.

- xxi) The contract will be implemented strictly as per specification and all other conditions of APL General Direction and Conditions of Contract.
- xxii) The Company also reserve the right to add or make any amendment of the above clauses as and when company feels necessary depending upon the changing situation.

xxiii) Any dispute and subsequent course of action relating to the contract will be deemed to have arisen within jurisdiction of Dibrugarh Court only, no other court.

xxiv) **TERMINATION OF CONTRACT**:

If Contractor shall neglect to execute work with due diligence or expedition, or shall refuse or neglect to comply any reasonable order given to it in writing / or oral by Management of APL in connection of work, or shall contravene any of the provisions of the contract, Company / Management may give notice in writing to contractor calling upon it to make good the failure, neglect or contravention complained of, within a period of 30 (Thirty) days. If contractor defaults to comply with any such notice, the Management may without prejudice terminate the contract.

6. INCOME TAX AND GST

- i. Income tax at the prevailing rate shall be deducted from the BIDDER's bills as per Income Tax Act. OWNER shall issue necessary TDS Certificate to the BIDDER.
- ii. The quoted price shall be deemed to be inclusive of all taxes and duties except "Goods and Service Tax" (hereinafter called GST) (i.e. IGST or CGST and SGST / UTGST applicable in case of interstate supply or intra state supply respectively.)
- iii. Bidder /vendor shall be required to issue tax invoices in accordance with GST Rules so that input credit can be availed by OWNER / APL. In the event that the bidder / vendor fails to provide the invoice in the form and manner prescribed under the GST Act read with GST Invoicing Rules there under, OWNER / APL shall not be liable to make any payment against such invoice.



iv. GST shall be paid against receipt of tax invoice and proof of payment of GST to government in India or upon the same being reflected in the GST portal of the APL to the satisfaction of APL. In case of non-receipt of tax invoice or non-payment of GST by the bidder / vendor, OWNER / APL shall withhold the payment of GST.

- v. GST payable under reverse charge , if any shall not be paid to the bidder /vendor but will be directly deposited to the government of India.
- vi. Notwithstanding anything contained anywhere in the Agreement, in the event that the input tax credit of the GST charged by the Bidder/Vendor is denied by the tax authorities to OWNER / APL due to reasons attributable to Bidder /Vendor, OWNER / APL shall be entitled to recover such amount from the Bidder/Vendor by way of adjustment from the next invoice or from Bank Guarantee . In addition to the amount of GST, OWNER / APL shall also be entitled to recover interest at the rate of 24% and penalty. In case any penalty is imposed by the tax authorities on OWNER / APL.
- vii. TDS under GST, if applicable, shall be made from bidder's /Vendor's bill at applicable rate and a certificate as per rules for tax so deducted shall be provided to the bidder /Vendor.
- viii. No variation on account of taxes and duties, statutory or otherwise, shall be payable by Client to bidder/vendor except for GST. However, any statutory variation for GST shall be payable up to contractual date of completion against documentary evidence. Any reduction in taxes and duties included in the price shall be passed on to OWNER / APL.
- ix. Any new taxes, duties, cess, levies notified or imposed after the submission of last/ final price bid but before the contractual date of completion of work shall be to OWNER / APL's Account. 

the execution of the contract or to any third person any material or immaterial benefit which he / she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the tender process or during the execution of the contract.

- b) The Bidder / Bidder will not enter with other Bidders into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.
 - c) The Bidder / Bidder will not commit any offence under the IPC / PC Act; further the Bidder / Contactor will not use improperly, for purposes of competition or personal gain, or pass on to others, any information or document provided by the Principal as part of the business relationship
 - d) The Bidder / Bidder will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the contract.
- (2) The Bidder / Bidder will not instigate third persons to commit offences outlined above or be an accessory to such offences.

Section 3 - Disqualification from tender process and exclusion from future contracts

If the Bidder, before award of contract has committed a transgression through a violation of Section 2 or in any other form such as to put his reliability or credibility as Bidder into question, the Principal is entitled to disqualify the Bidder from the tender process or to terminate the contract, if already signed, for such reason.

- (1) If the Bidder / Bidder have committed a transgression through a violation of Section 2 such as to put his reliability or credibility into question, the Principal is entitled also to exclude the Bidder / Bidder from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of the transgression. The severity will be determined by the circumstances of the case, in particular the number of transgressions, the position of the transgressors within the company hierarchy of the Bidder and the amount of the damage. The exclusion will be imposed for a minimum of 6 months and maximum of 3 years.
- (2) The Bidder accepts and undertakes to respect and uphold the Principal's absolute right to resort to and impose such exclusion
- (3) Apart from the above, the Principal may take action for banning of business dealings / holiday listing of the Bidder as deemed fit by the Principal.
- (4) If the Bidder / Bidder can prove that he has restored / recouped the damage caused by him and has installed a suitable corruption prevention system, the Principal may revoke the exclusion prematurely.
- (5) A transgression is considered to have occurred if in light of available evidence no reasonable doubt is possible.



Section 4 - Compensation for Damages

1) Without prejudice to any rights that may be available to the Principal under law or the Contract or its established policies and laid down procedures, the Principal / Owner shall have the following rights in case of breach of this Integrity Pact by the Bidder/ Bidders): Forfeiture of EMD / Security Deposit: If the Principal has disqualified the Bidder(s) from the Tender process prior to the award of the Contract or terminated the Contract or has accrued the right to terminate the Contract according to Section 3, the Principal apart from exercising any legal rights that may have accrued to the Principal, may in its considered opinion forfeit the Earnest Money Deposit / Bid-Security amount of the Bidder / Bidder.

- (2) If the Principal has terminated the contract according to Section 3, or if the Principal is entitled to terminate the contract according to Section 3, the Principal shall be entitled to demand and recover from the Bidder liquidated damages equivalent to 5% of the contract value or the amount equivalent to Security Deposit / Performance Bank Guarantee, whichever is higher.
- (3) The bidder agrees and undertakes to pay the said amounts without protest or demur subject only to condition that if the Bidder / Bidder can prove and establish that the exclusion of the Bidder from the tender process or the termination of the contract after the contract award has caused no damage or less damage than the amount of the liquidated damages, the Bidder / Bidder shall compensate the Principal only to the extent of the damage in the amount proved.

Section 5 - Previous Transgression

- (1) The Bidder declares that no previous transgressions occurred in the last 3 years with any other Company in any country conforming to or with any other Public Section Enterprise in India that could justify his exclusion from the tender process.
- (2) If the Bidder makes incorrect statement on this subject, he can be disqualified from the tender process or the contract, if already awarded, can" be terminated for such reason.
- (3) If the Bidder / Bidder can prove that he has resorted / recouped the damage caused by him and has installed a suitable corruption prevention system, the Principal may, at its own discretion as per laid down organizational procedures, revoke the exclusion prematurely.

Section 6 - Equal treatment of all Bidders / Bidders / Sub-Bidders

- (1) The Bidder / Bidder undertake to demand from all sub bidders a commitment in conformity with this Integrity Pact. The Bidder / Bidder shall be responsible for any violation(s) of the principles laid down in this agreement / Pact by any of its Sub bidders / Sub-vendors.
 - (2) The Principal will enter into agreements with identical conditions as this one with all Bidders and Bidders.
 - (3) The Principal will disqualify from the tender process all bidders who do not sign this pact or violate its provisions.

Section 7 - Criminal charges against violating Bidders / Bidders / Sub- Bidders



If the Principal obtains knowledge of conduct of a Bidder, Bidder or Sub-Bidder or of an employee or a representative or an associate of a Bidder, Bidder or Sub-Bidder which constitutes corruption, or if the Principal has substantive suspicion in this regard, the Principal will report to appropriate authority in this regards.

Section 8 - External Independent Monitor / Monitors (number depending on the size of the contract to be decided by the Chairperson of the Principal)

- (1) The Principal appoints competent and credible external independent Monitor for this Pact. The task of the Monitor is to review independently and objectively, whether and to what extent the parties comply with the obligations under this agreement.
 - (2) The Monitor is not subject to instructions by the representatives of the parties and performs his functions neutrally and independently.
 - (3) The Bidder accepts that the Monitor has the right to access without restriction to all Project documentation of the Principal including that provided by the Bidder. The Bidder will also grant the Monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his project documentation. The same is applicable to Sub-bidders. The Monitor is under contractual obligation to treat the information and documents of the Bidder / Bidder / Sub-contractor with confidentiality.
 - (4) In case of tenders having an estimated value of Rs.100 Crore, the Principal will provide to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the Principal and the Bidder.
 - (5) As soon as the Monitor notices, or believes to notice, a violation of this agreement, he will so inform the Management of the Principal and request the Management to discontinue or to take other relevant action. The Monitor can in this regard submit non-binding recommendations. Beyond this, the Monitor has no right to demand from the parties that they act in a specific manner, refrain from action or tolerate action.
- (6) The Monitor will submit a written report to the CEO of the Principal within 2 weeks from the date of reference or intimation to him by the 'Principal' and, should the occasion arise, submit proposals for correcting problematic situations.
- (7) If the Monitor has reported to the CEO of the Principal substantiated suspicion of an offence under the IPC / PC Act and the CEO has not, within reasonable time, taken visible action to proceed against such offence or reported it to the Vigilance Office, the Monitor may also transmit this information directly to the Central Vigilance Commissioner, Government of India,
- (8) The word 'Monitor' would include both singular and plural.

Section 9 – Pact Duration

This Pact begins when both the parties have legally signed it. It expires for the Bidder / Bidder 12 months after the completion of work under Contract or till the continuation of guarantee period, whichever is more and for all other bidders, till the contract is awarded.

If any claim is made / lodged during this time, the same shall continue to be valid despite the lapse of this pact as specified it is discharged / determined by the CEO of the Principal.

Section 10 - Other Provisions

- 1) This agreement is subject to Indian as well as state of Assam local laws. Place of performance and jurisdiction is the Registered Office of the Principal, i.e. Guwahati.
- 2) Changes and supplements as well as termination notices need to be made in writing. Side agreements have not been made.
- 3) If the Bidder is a partnership or a consortium, this agreement must be signed by all partners or consortium members.
- 4) Should one or several provision of this agreement turn out to be invalid the remainder of this agreement remains valid. In this the parties will strive to come to an agreement to their original intentions.
